Coach Supervision Session Tariff

Hello,
My aim in life is to help as many people as possible through my coach supervision. I appreciate that not everyone has the budget to afford my services so I offer a range of tariffs that will make it easier for anyone, regardless of their financial position, to access the help they need.

I therefore ask you to choose one of the following options:

I currently have no disposable income and would like to apply for six free supervision sessions to be conducted at agreed intervals.

I have minimal disposable income but can pay £60 (includes VAT) per session. I would like six coach supervision sessions at agreed intervals.

I have limited disposable income but can pay £120 (includes VAT) per session for six coach supervision sessions at agreed intervals.

I am ok for disposable income and can pay the standard rate of £180.00 (includes VAT) per session. I would like a minimum of six sessions at agreed intervals.

I am very well off and would like to pay double the standard rate, £360 (including VAT) per session or an agreed rate to fund another person who is unable to pay at the current time. I would like a minimum of six sessions at agreed intervals.

I would like to discuss an alternative arrangement to those listed above.

Terms and Conditions

These rates apply to online sessions. Face to face rates are negotiable based on travel distance and length of sessions.

Contracts are for a minimum of 6 sessions. Other options such as face to face and 2, 3 or 4 day intensives are also available.

To get the best out of supervision we will meet at agreed intervals, based on your volume of coaching, but as a minimum four sessions per year.

Monthly payment arrangements should be made by standing order. Session by session arrangements will be invoiced on the day of the session and should be paid by BACS (or Paypal for overseas clients), within 7 days.

We reserve the right to charge the full agreed rate for sessions if they are cancelled in the 7 days leading up to the session. We appreciate that circumstances might require sessions to be rearranged at short notice and decisions about cancellation fee will be made on a case by case basis.

We reserve the right to cancel the arrangement for free or reduced rate sessions if two sessions are cancelled at short notice. The decision will not be taken lightly and will be considered on a case by case basis.

A limited number of free and reduced cost sessions will be made available every six months. If these spaces are full, then your name will be added to a waiting list and the next person will be contacted when the space becomes available, or if a kind sponsor covers the cost. Free spaces may not be allocated on a first come first served basis. Priority will be given to the most needy cases.
