**Coach Supervision Session Tariff**

Hello,  
My aim in life is to help as many people as possible through my coach supervision. I appreciate that not everyone has the budget to afford my services so I offer a range of tariffs that will make it easier for anyone, regardless of their financial position, to access the help they need.

I therefore ask you to choose one of the following options:

I have minimal disposable income but can pay £240 (includes VAT) for the 6 month supervision group.

I have limited disposable income but can pay £360 (includes VAT) for the 6 month supervision group.

I am ok for disposable income and can pay the standard rate of £480.00 (includes VAT) for the 6 month supervision group.

I am very well off and would like to pay double the standard rate, £960 (including VAT) for the 6 month supervision group (or an agreed rate) to fund another person who is unable to pay at the current time.

I would like to discuss an alternative arrangement to those listed above.

## **Terms and Conditions**

These rates apply to online programme only.

Contracts are for a specific supervision group which will include 6 x 2 hour monthly sessions over a period of a pre determined 6 months.

Payment in full should be paid by BACS (or Paypal for overseas clients) prior to the start of the supervision group, unless alternative payment arrangements have been agreed.

As the supervision groups are closed groups, no refunds of payment will be made from 7 days prior to the start of the group sessions. We appreciate that circumstances might change which will make it difficult or impossible to attend the programme. In these cases the fee may be carried over to another group at our discretion. Decisions about cancellation fee will be made on a case by case basis.

A limited number of free and reduced cost sessions will be made available for each supervision group. If these spaces are full, then your name will be added to a waiting list and you may be contacted when a space becomes available, or if a kind sponsor covers the cost.

Free spaces may not be allocated on a first come first served basis. Priority will be given to the most needy cases and/or those who are applying for the first time.

We reserve the right to cancel the arrangement for free sessions, due to non attendance of two sessions. The decision will not be taken lightly and will be considered on a case by case basis.
